

NOTIFICATION

The Govt. of Assam in Higher Education Department is pleased to allow to give approval to the Governing Body of the Provincialised Colleges of Assam for filling up of vacant sanctioned post of Assistant Professors of provincialised Colleges of Assam after satisfying the following terms and conditions :

1. Approval of the Roster for filling up the vacant posts from the Government.
2. 38 years as on the 1st day of the year in which the advertisement is issued with relaxation of 5 years for SC/ST/PwD and 3 years for OBC/MOBC candidates. Advertisement must be published in two leading daily News Papers of Assam with clear 15 days time and the whole process of selection of candidate should be completed on or before 45 days, advertisement to appear in College website.
3. Fulfillment of Educational Qualification as per Govt. OM No.AHE.407/2017/44 dated 08-11-2018.
4. Reference date for acquiring qualification : Candidate has to acquire qualifications as on the last date for submitting applications. Eligibility like M.Phil/Ph.D/Seminar Paper/Publications can be acquired and submitted on date of interview and not beyond.
5. Governing Body of the College should ascertain that the posts are not subjudiced/personal post and not already withdrawn by the Government.
6. Governing Body of the College should give an undertaking that the concerned sanctioned post has not be previously filled up on falling vacant.
7. The Governing Body of the College should ensure that the posts shall be filled with strict compliance with the provisions of the AFRBM Act, 2005, existing reservation Act and Rules, Rulings of the Hon'ble Supreme Court as well as order of Hon'ble High Court and in accordance with the Service Rules and due procedures established by law and also filling up the vacant post against sanctioned vacant posts only.


